

Not to engage in unsportsmanlike conduct with any skater, coach, official, vendor or any other attendee. Not to engage in any behavior which would endanger the health, safety or well-being of any skater, coach, official, vendor or any other attendee.

Not to engage in the use of profanity.

I will treat any skater, coach, official, vendor, or any other attendee with respect regardless of race, creed, color, national origin, sex, sexual orientation, or ability.

I will not engage in verbal or physical threats or abuse aimed at any skater, coach, official, vendor, or any other attendee.

I will not initiate a disturbance or fight with any skater, coach, official, vendor or any other attendee.

I hereby agree that if I fail to conform my conduct to the foregoing while attending, coaching, officiating, or participating in a US Roller Speed Skating competition, I will be subject to disciplinary action, including but not limited to the following in any order or combination:

- a. Verbal warning.
- b. Written warning.

- c. Suspension or immediate ejection from a USRSS competition issued by the Lead Track Official or Competition Manager.
- d. Suspension from multiple USRSS competition issued by the USRSS Board or their designee.
- e. Season suspension or multiple season suspension issued by the USRSS Board or their designee.
